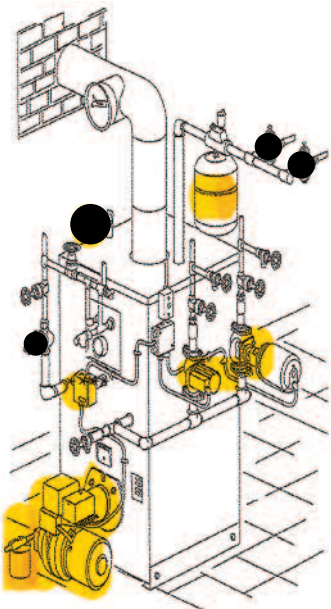

GENERAL CONDITIONS

This agreement is offered subject to inspection and approval of equipment. Any repairs required to place equipment in acceptable condition are excluded and will be charged separately.

These agreements do not include the cost of labor or materials for repairs and/or replacement resulting from wars, floods, lightning, earthquakes, storms, fire, smoke, electrical failures, strikes, roots, freeze-ups, government regulations, force majeure and/or acts of God.

Discount Fuel Burner Service shall not be liable for loss, damage or injury caused by failure to delay in performing the services outlined herein. It is the customer's responsibility to shut off the oil burner and notify Discount Fuel Burner Service immediately if there is an operational problem.

The following are excluded: **all switching relay(s), zone valve power heads**

Repair or replacement of defects in hot or cold water pipes, heating system piping, radiators, baseboard convertors, boiler, furnace, domestic relief valve, electric wiring, oil feed and return lines, flue pipes, electric and manual clock thermostats, tork clocks, low water cut-off, automatic water feeder for steam system, water tempering valves, domestic water coils water tanks, valves, vents, humidifier plates, air filters, **blower** assembly, combustible chambers, discontinued or obsolete parts, special control systems, rewiring, alterations, installing of parts not presently in the system. Also damage caused by an insufficient supply of water, by a manual or automatic water feeder failure or due to the failure of a low water cut-off.

This agreement does not cover service rendered as a result of a customer failure to replace a fuse, reset a circuit breakers set thermostat properly, turn on emergency switch, open fuel valve, bleed air, add water when needed to steam systems, oil al motors and circulator pumps, replace air filters, wix filter and drain expansion tank. Further, this agreement does not cover water leaks on any plumbing parts or piping. Service required or damage resulting from power failures: the running out of oil and oration of an attic fan is not covered. (NOTE: Simultaneous operation O1 an attic fan and oil burner can cause oil burner to malfunction.)

Discount Fuel Burner Service will use its best efforts to effect prompt performance of the service covered herein, but it shall have no liability for any delays of the consequences thereof. Discount Fuel Burner Service obligations and liability hereunder in rest to the manner in which this agreement is performed shall in all events be limited to correction of the condition on which the service call is based. Discount Fuel Burner Service shall incur no liability whatsoever for any soot, smoke, fire, water or freeze-up damages to owner's property as a result of services rendered.

This is a comprehensive service and parts agreement, not a guarantee. There are no promises, representations, expressed or implied other than those herein. Said agreement may be cancelled by either party on thirty (30) days written notice. In event of cancellation by the customer, no refund will be allowed on any unused portion of this agreement. Discount Fuel Burner Service reserves the right to inspect all heating systems before acceptance of said agreement for any new owner of the heating system covered herein. Prices and conditions subject to change without notice at time of renewal.

All services must be performed by Discount Fuel Burner Service representatives. During the evening hours and Saturday and Sunday and holidays only EMERGENCY service will be rendered.

Discount Fuel Burner Service and customer agree that there are no promises, terms, conditions, or obligations not herein written which is a part of this agreement. This Plan supersedes all prior service plans.

Discount Fuel Burner Service shall have the right to discontinue this contract if customer fails to comply with Discount Fuel Burner Service payment terms set forth in this contract. If Discount Fuel Burner Service exercises this right, Discount Fuel Burner Service shall not be liable for any damages, including consequential and incidental damage due to loss of heat, frozen pipes, or other occurrences resulting from cancellation on of this contract. If customer fails to comply with Discount Fuel Burner Service payment terms set forth in this contract. If Discount Fuel Burner Service does not exercise its right under this paragraph, Discount Fuel Burner Service failure to exercise its right shall not constitute a waiver of its right under this paragraph.

As a condition of this agreement you hereby agree to make any repairs outside the realm of normal service if notified in writing by Discount Fuel Burner Service.
